Maraimalai Nagar, Ninnakarai Village, Chengalpattu Taluk, Kancheepuram District- 603 209, Tamil Nadu is run by Sivananda Sarawathi Sevashram Mangalam Trust, which is duly registered under Document No.820/1969 dated 31/03/1969 on the file of Sub-Registrar Office, Chengalpattu, with the intent to effectively provide quality education to the children in the area where the said school is located.

The school has started on 01/06/2015 with the strength of nearly 500 pupils (from Pre KG to V<sup>th</sup> Std).

4) That the Trust managing and running the above said school is of non-proprietary in character and that the members of the said Trust are listed as follows under the heading School Management Committee, which is well organised as per the norms of the Society/trust Act and the members have been duly elected.
